- The GB resolved to apply for AICTE Extended EOA since live autonomy period conferred by affiliating university (JNTUH) and UGC is valid beyond 10<sup>th</sup> April 2019 as per the AICTE approval process handbook 2018-2019.
- The GB resolved to apply for NBA accreditation for B. Tech UG course in Civil Engineering under Tier-I.
- The GB Resolved to submit Pre-qualifier / Compliance for Re-accreditation for B. Tech Courses CSE, IT, ECE, EEE & MECH under Tier-I.
- 6. The GB was noted the proposed modified curriculum follows AICTE model curriculum.
- 7. The GB authorized principal to recruit faculty as per the requirement and resolved to ratify the existing faculty (new incumbents) in their respective positions.
- The GB resolved to renew VCE membership with SIRO (DSIR) as the expiry is scheduled as of 31-03-2018.
