Section 2: ITEMS FOR APPROVAL/RATIFICATION

27.2.1 CHANGES IN PROGRAMMES / COURSES AND INTAKE TO BE OFFERED FROM THE ACADEMIC YEAR 2022-2023

While referring to the affiliating university (JNTUH) Cir.No: JNTUH/UAAC/NOC/2023-24, dated 02-01-2023, regarding application for "No Objection Certificate", the Member Secretary proposed the changes in programmes / courses to be offered from the Academic Year 2023-2024. In continuation, it is informed that, the required documents towards the same were submitted to the JNTUH with the approval of Chairman.

After detailed discussion the GB resolved for the,

- 1. Merger of the Courses (s)
 - a. <u>UG B.Tech. Artificial Intelligence (AI) and Data Science</u> from existing <u>120</u> to <u>0</u>.
 - b. <u>UG B.Tech. Artificial Intelligence and Machine Learning</u> from existing <u>120</u> to <u>0</u>.
 - c. <u>UG B.Tech. Computer Science and Engineering</u> from existing <u>240</u> to <u>480</u>.
- 2. Increase in Intake in <u>UG B.Tech. Computer Science and Engineering (Data Science)</u> from existing <u>60</u> to <u>180</u>.
- 3. Reduction in Intake in <u>UG B.Tech. Mechanical Engineering</u>, from <u>60</u> to <u>30</u>.

Further, the GB resolved to allocate the Land/Building/funds for the above proposed activities.
